The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.


The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet



The school all labs needs to be enriched with more equipment's & etc. further, the labs equipment, reagents and specimens etc. kept in laboratories shall be in accordance with the laws, rules and regulations applicable. 2. As per online form Part- A the details of Laboratories including Physics, Chemistry & Bio Labs are (522 Sq. ft.) whereas the Physics, Chemistry & Bio Labs should be minimum 600 Sq. ft. as per Affiliation Bye-Laws. Therefore, the school is required to shift Physics, Chemistry & Bio Labs into bigger room of 600 Sq. ft. within 03 months. 3. The school is required to ensure time to time renewal of all mandatory safety certificates.



7. The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.
8. The school may make provision to establish rain water harvesting system in their school premises as per Board's circular no. CBSE/AFF./AC/RWH/2025 dated 24.03.2025.

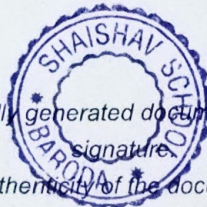
